PETITION FOR REVIEW
(ORAP 11.35 – temp. eff. Aug. 1, 2021, to Dec. 31, 2022)

1. Petitioners are Qualified Electors of the State

Petitioners are qualified electors of the state of Oregon. Prior to September 27, 2021, they were (1) at least 18 years of age, (2) had resided in this state for more than six months, and (3) had been registered to vote in the state of Oregon for more than 20 days. Or Const, Art II, § 2; ORS 247.002(2).

2. Petitioners’ Prayer for Specific Relief

Petitioners request this Court to review the plan for the reapportionment of the state legislative districts, both Senate districts and House districts, adopted by

the Oregon Legislature as SB 882 (2021) on September 27, 2021. Petitioners pray this Court issue an opinion and direct the Secretary of State to correct the reapportionment plan pursuant to this Court's opinion and Petitioners' arguments. Petitioners pray that this Court, in issuing its opinion, recognize that the Equitable Map Oregon Plan is a lawful reapportionment plan, and it meets constitutional and statutory requirements, and that this Court direct the Secretary of State to implement the Equitable Map Oregon Plan in place of SB 882.
