AFFIDAVIT OF DOUG MARTEENY

I, Douglas R. Marteeny, being first duly sworn, state as follows:

I have personal knowledge of the matters set forth herein and say the following to the best of my knowledge.

- 1. I am the District Attorney for Linn County.
- 2. In 2020, I was informed by the Oregon District Attorneys Association that the Governor was considering commuting a large number of sentences of criminals currently in Department of Corrections (DOC) custody.
- 3. Periodically, in 2020 and 2021, I was provided a list of individuals that DOC was considering to recommend to the Governor for commutation. These lists came to be referred to as "rounds" of people to be considered by the Governor. (The term "rounds" was used in my correspondence with the DOC.) (Ex. 1)
- 4. As this new process for commutation consideration developed, I was provided with a form from DOC Entitled "Potential Sentence Commutation Feedback Form" (Feedback Form.) The form had specific fields for me to fill in to provide feedback. (Ex. 2)
- 5. I would receive an e-mail from DOC providing the Feedback Form. In that e-mail DOC would often provide a deadline for me to provide feedback. The timeline for me to provide feedback was usually very short. (For example, in Ex. 2, the deadline was 8 days which included a weekend.)

- 6. The Feedback Form asked me not to respond "UNLESS YOU HAVE CONCERNS WITH THE POTENTIAL COMMUTATION OF THE ABOVE AIC'S SENTENCE." (Id.)
- 7. The Feedback Form provided to me did not inquire or request feedback or statements from crime victims. (Id.)
 - 8. The DOC requested that all filled out feedback forms be returned to the DOC.
- 9. My office objected to almost every commutation that the DOC asked for our feedback on.
- 10. On at least one occasion after one of my objections, the DOC asked for additional information from me to supplement my objection. I provided additional information they requested. (Ex. 3)
- 11. I inquired, and would receive periodic updates from the DOC as to which of the AICs being considered for commutation were ultimately granted a commutation. (Ex 4)
- 12. The process for commutation review described above was followed in 2020 and 2021 at least through May 21, 2021. There were at least 6 rounds of review of AIC names during that time period. These 6 rounds of commutation review were referred to as "COVID related" commutations and "Wildland Firefighter" commutations. COVID-19, and assisting in fighting forest fires in Oregon were the reasons provided as to why these 6 rounds of commutations were made. On July 6, 2021, I was informed by the DOC that the Governor has decided to not move forward with additional COVID related commutations at this time. (Ex 5)

13. In those 6 rounds of commutations, Linn County had over 50 AICs sentences

commuted.

14. Later in October 2021, I was informed by the Oregon District Attorney's

Association that the Governor had granted additional commutations. This time, sentences of

juvenile offenders had been commuted. It was identified that there were two rounds of juvenile

commutations. The first round of juvenile commutations had already been granted. I was told

that this first round of juvenile commutations didn't release the juveniles, but attempted to set up

a system where they will appear before the parole board for further review and the Parole Board

will ultimately determine whether they will be released early. From what I could tell from the

materials provided to me by the Oregon District Attorneys Association, Linn County did not

have any offenders on this first round of juvenile offender commutations.

15. I was also informed that there is a second list of juvenile offenders that would be

eligible for early release through commutation once they have first served 50% of their sentence.

Once 50% of the sentence has been served, they will then be eligible to appear before the Parole

Board to be considered for early release. It appears that Linn County has 6 juvenile offenders on

that list.

16. For the 6 rounds of AIC commutations listed above, and the 2 rounds of juvenile

commutations described, I have not received any applications from the offenders themselves, as

required by ORS 144.650.

17. After many of the commutations describe above were granted and AICs returned

to our communities in Linn County. Some of them returned to committing crimes.

Kevin L. Mannix, P.C. 2009 State Street 18. I was informed by a representative of the Governor's office that all of the commutations granted were "conditional" commutations and that the Governor maintained the

power to revoke the commutations.

19. Subsequent to these commutations, a commutation recipient, shortly after being

released, committed new crimes. I inquired with a representative of the Governor's office what

the process was for a conditional commutation to be revoked. The Governor's representative

responded that they would be happy to discuss a particular case over the phone. (Ex. 6)

20. I prepared a written request to revoke a commutation that had been granted to,

Pablo Francisco, a commuted AIC that had committed a number of new crimes shortly after his

commutation release. (Ex 7) I have since been informed that Mr. Francisco's commutation had

been revoked by the Governor.

21. Based upon the above, I do not believe that the Governor has complied with the

commutation process outlined in ORS 144.650.

22. Additionally, by granting juvenile commutations in a manner that sets up a new

parole board process not reflected in the original sentence judgments, the Governor has

attempted to grant a commutation that adds a penalty process, to wit: Parole Board hearing and

oversight that previously had not been ordered. However, ORS 144.649 only allows the

Governor's commutation to "remit" a penalty, not add a sanction. The commutation power does

not grant the Governor the ability to establish a new alternative penalty of being subject to a

Parole Board hearing and oversight. In this way, and the other ways cited above, I believe the

Governor has attempted to exercise powers not granted to her in her commutation powers, and
has violated established laws regarding the parameters of the clemency process.



Thank you for fielding our questions today. You provided your e-mail address to follow up with my questions. Thank you. The questions I have are as follows:

1) May I be provided with a copy of the report that the Governor provided to the legislature reporting on how many commutations the Governor has provided?

Attached is the letter that the Governor sent to the legislature. I also provided this document to Michael Wu.

2) Since January 2020, how many commutations are not reflected in that report? This will help me answer the questions that I receive locally which are: how many commutations has the Governor handed down.

The attached report to the legislature answers your question in part, because it includes all commutations through June 2021. Our office compiles this clemency information and prepares a similar report at the end of each legislative session, so we will have additional information that we can send you early next year. I'd be happy to send that information your way, if it would be helpful.

3) You mentioned that the commutations are conditional and can be revoked. How do we submit a request that a particular commutation be revoked?

If either now or later you have a question about a particular case from Linn County, I am happy to discuss with you by phone.

4) You indicated that you are aware of the instances when commuted individuals commit new crimes. May I also receive a list of how many of these commuted individuals have committed new crimes?

I can look into getting information for you. In the meantime, if you have a question about a particular individual from Linn County, I would be happy to discuss specifics with you over the phone.

Thank you for fielding our questions today. You provided your e-mail address to follow up with my questions. Thank you. The questions I have are as follows:

1) May I be provided with a copy of the report that the Governor provided to the legislature reporting on how many commutations the Governor has provided?

Attached is the letter that the Governor sent to the legislature. I also provided this document to Michael Wu.

2) Since January 2020, how many commutations are not reflected in that report? This will help me answer the questions that I receive locally which are: how many commutations has the Governor handed down.

The attached report to the legislature answers your question in part, because it includes all commutations through June 2021. Our office compiles this clemency information and prepares a similar report at the end of each legislative session, so we will have additional information that we can send you early next year. I'd be happy to send that information your way, if it would be helpful.

3) You mentioned that the commutations are conditional and can be revoked. How do we submit a request that a particular commutation be revoked?

If either now or later you have a question about a particular case from Linn County, I am happy to discuss with you by phone.

4) You indicated that you are aware of the instances when commuted individuals commit new crimes. May I also receive a list of how many of these commuted individuals have committed new crimes?

I can look into getting information for you. In the meantime, if you have a question about a particular

individual from Linn County, I would be happy to discuss specifics with you over the phone.

Governor Brown and Director Peters,

Mr. Pablo Sebastian Francisco was sentenced on January 15, 2020 on two separate cases involving Unauthorized Use of a Vehicle. Between those two cases, he was sentenced to serve 30 months in Department of Corrections (DOC) custody. Unfortunately, Mr. Francisco was granted a commutation over my objection (Ex. 1.) Within a short while after his release from DOC custody, Mr. Francisco committed the same crime again. Additionally, he drove 50-60 mph in a 25 mph residential neighborhood, blowing through stop signs, all while intoxicated. When caught and put into a jail cell, he smeared his own excrement on the jail cell walls. I have included a copy of the P.C. Affidavit for this newest case. (Ex 2.)

Mr. Francisco has now been convicted for those new crimes and has been sent back to prison. Because Mr. Francisco's commutation was a conditional one, I am requesting that you now revoke his previously granted commutation in its entirety requiring that the previous sentences not run concurrent with his newest one. Additionally, with this letter, I am asking that the DOC also revoke and deny Mr. Francisco all reduction in sentence calculations. The evidence presented here shows that Mr. Francisco is not worthy of those reductions and they should not be granted to him.



Oregon Administrative Rules Sentencing Guidelines. That is the most aggravated posture a defendant may have in terms of prior criminal history. The case in which Mr. Francisco is currently under consideration for commutation is his third prison sentence. Eight of his fifteen criminal convictions are for crimes against other people. One of those cases for which he has been convicted, but where it is not a person crime, is an instance where he broke into his parent's neighbor's home to steal property. His mother had to call the police to report his crime after she physically tried to get him to stop the theft. He's serving the present prison sentence after, in two separate and distinct incidents, driving and using in vehicles recently stolen from two separate victims. He is 36 years old. Mr. Francisco, at this point in his life, poses a risk to the community that could otherwise be avoided if he were to finish out the remainder of his sentence.

Summary of Probable Cause: On 05/16/2021, at approximately 2019 hours, I was dispatched to a Attemptt to Locate DUII call on Santiam Highway and Goldfish Farm Road in Albany, Linn County, Oregon. Dustin Smith reported there was a small white vehicle swerving all over the road. Dustin reported the vehicle almost went off the road several times and he was concerned the vehicle was going to hit someone head on. Dustin reported he was unable to keep up with the vehicle because it was now speeding at approximately 70 mph. The area Dustin was reporting this was a posted 45 mph zone. Dustin reported he lost site of the vehicle as it crossed over the Interstate 5 overpass east on Santiam Highway. Dustin provided the license plate which was Washington plate BIE210. Albany Police Dispatch advised this came back to a stolen Ford Fiesta white in color. Dispatch later confirmed the vehicle was stolen.

I located the vehicle eastbound on Santiam Highway and it turned north onto Waverly Drive. The vehicle failed to maintain lane and it would slow down and speed up. I followed it for several blocks and observed the vehicle continue to vary its speed. I activated my emergency lights in attempt to stop the vehicle and it continued at a low rate of speed and the driver would act like he was going to pull over then take off again. The driver took off northbound on Geary Street towards Salem Avenue at approximately 50 mph.

The driver blew through the stop sign at the intersection of Geary Street and Salem Avenue and almost hit a truck that was eastbound on Salem Avenue. The driver then turned westbound on 2nd Avenue and blew through several stops signs at approximately 50 to 60 mph in a residential neighborhood which is a 25 mph zone. The driver then turned into a driveway near the 1100 block of SE 2nd Avenue and bailed from the car and ran on foot. The driver tried to run into the front door of 1120 Salem Avenue SE but the door was locked. The driver was taken into custody and identified as Pablo Francisco. Pablo's eye's were bloodshot and watery and his speech was slurred. Officer Corbett advised me that he could smell an odor of an alcoholic beverage coming from Pablos's person as he was trying to interview him. Sgt. Corbett also advised me that he observed Pablo's speech was slurred and his eyes were bloodshot and watery. Pablo was not compliant when transported back to the Albany Police Department. Pablo was placed in a holding cell. While in the holding cell, Pablo was wiping feces from his groin area and throwing the toilet paper all over the floor and walls of the cell. I have probable cause to charge Pablo with the above listed crimes.
